

**NIJIYA MARKET YEAR END SWEEPSTAKES (the “Sweepstakes”) OFFICIAL RULES**  
**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCE OF WINNING. WINNERS ARE RESPONSIBLE TO PAY TAXES ON PRIZES, IF APPLICABLE.**

1. **SPONSER.** The Sweepstakes is sponsored by Jinon Corporation DBA Nijiya Market.
2. **DATES OF SWEEPSTAKES.** Sweepstakes begins on December 1, 2020 and ends at December 7, 2020 (The “Sweepstakes Period”)
3. **ELIGIBILITY.** Sweepstakes is open only to legal residents of the State of California and the State of Hawaii who are eighteen (18) years of age or older. Officers, directors, managers, and employees of Jinon Corporation are not eligible to participate.
4. **HOW TO ENTER.**  
**There are 2 ways to enter:**
  - (i) **PURCHASE.** Entrants making a purchase of over \$20.00 at any Nijiya Market retail location during store hours between the Sweepstakes period will receive one (1) entry form. Entrants must fill out the entry form at the time of purchase and submit the entry form at each retail location’s designated entry box.
  - (ii) **WRITE-IN.** On a postcard, legibly handwrite your complete name, mailing address, phone number and date of birth and mail with proper postage to: **Nijiya Market 2020 Sweepstakes, 2180 W. 190<sup>th</sup> St., Torrance, CA 90504.** All write-in entries must be postmarked during the Sweepstakes Period and received by December 14, 2020. Write in entries must be postmarked by the United States Postal Service and may not be dropped off or handed directly at any Nijiya Market retail location or offices. There is a limit of one (1) write-in entry per postcard. Each postcard is considered one (1) entry into the Sweepstakes. Any write-in entries missing information outlined above is not eligible. Nijiya Market is not responsible for lost, damaged, illegible, or postage-due entries. Proof of submission is not proof of receipt by Nijiya Market.
5. **DRAWING/ODDS.** On or about December 15, 2020, potential prize winners will be selected in a random drawing from all eligible entries received by Nijiya Market. Odds of winning depend on the number of eligible entries received for the Sweepstakes.
6. **PRIZES.**  
Prizes are Nijiya Market Promotional Gift Cards (the “Gift Cards”) and Nijiya Market Face Masks (the “Face Masks”). The Gift Cards have no cash value unless applicable by law and is set to expire on June 30, 2021. The Gift Cards will not be replaced if lost, stolen, damaged or expired. Face Masks are for non-medical purposes. Nijiya Market makes no claim that the Face Masks will prevent or protect from infections.

**SIXTH PRIZES.** SEVEN HUNDRED FIFTY (750) \$5.00 Nijiya Market Promotional Gift Cards  
**SEVENTH PRIZES.** SIX HUNDRED (600) Nijiya Market Face Masks.
7. **NOTIFICATIONS/CLAIMS.** All Prizes will be shipped to potential winners within 2 to 3 weeks of the drawing date via the United States Postal Service to the address provided on the entry form. If the prizes are returned due to insufficient addresses or undeliverable for any reason, the winner will be disqualified, and an alternate winner will be selected. If the alternate winner’s prize is returned due to insufficient address or undeliverable for any reason, no prize will be awarded.
